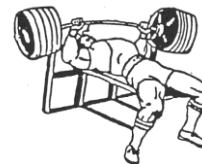
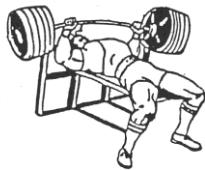
**Federation Membership Fee:** Current federation membership is required. Cards available online only <https://rawpowerlifting.com/member-login/>

**Release, Waiver of Liability, Assumption of Risk, Indemnity, and parental Consent Agreement ("agreement")**
