2) I, and the organization which I represent, shall abide by and implement the 100% RAW Powerlifting Federation Technical Rules in the conduct of the powerlifting meet; except that if a World Record lift is to be attempted (Sanctioned III (3) level meet only).

(3) I shall verify that all athletes participating in this powerlifting meet are registered with 100% RAW and hold current 100% RAW cards. I shall submit all proceeds from the sale of 100% RAW membership cards along with the tally sheets provided by the 100% RAW and a copy of the meet results to the 100% RAW office within 7 calendar days after the meet.

(4) I shall indemnify and hold harmless the 100% RAW POWERLIFTING FEDERATION INC, its members, officers, official agents, and employees, from and against any and all claims and liabilities, of whatever nature, including attorney's fees and costs occurred in defending in any legal or equitable action arising out of the conduct of this powerlifting meet.

(5) I am aware that 100% Raw is a drug-free Federation and attest that I will drug test (by urinalysis) no fewer than 10% of the lifters in this meet. I am aware I am responsible for payment of the drug tests.
